

## NTCAT FEES AS AT 1 JULY 2025

**Please note:**

1. NTCAT assesses fees based on whether the applicant is either an individual or a body corporate. In all cases the applicant must pay the NTCAT fee.
2. A body corporate includes a registered company (eg. Pty Ltd, publicly listed company etc.), units plan bodies corporate and incorporated associations.

(c) where the application includes a claim for a monetary amount that is more than \$10 000: (i) for an individual  (ii) for a body corporate	\$504  \$630
(d) where the application includes a claim for a monetary amount but the amount is not specified in the application: (i) for an individual  (ii) for a body corporate	\$504  \$630
(e) where the application does not include a claim for a monetary amount: (i) for an individual  (ii) for a body corporate	\$82  \$102
